Special Enrollment Period

A Special Enrollment Period is a period outside of Open Enrollment, in which you can get coverage due to Qualifying Life Events. You may qualify for this Special Enrollment if you miss a deadline, have a change in family status, lose your plan, or have one of many hardships. Are you thinking about moving, getting married, or having a baby? When you make big decisions in life you may become eligible for coverage outside of Open Enrollment through this Special Enrollment Period. Examples of “Qualifying Life Events” are...birth or adoption, divorce, becoming pregnant, your child is going to turn 26, death, gaining or losing a dependent, moving to another state, changes in income, you or your family are no longer eligible for Medicaid or CHIP, disability status, tax filing status, change of citizenship or immigration status, or release of incarceration. If any of these things have happened in your life recently, and you don't have health coverage, YOU may qualify for this Special Enrollment Period.

Tortellini-Asparagus Salad

Ingredients:

- *1 (9 Ounce) Package of refrigerated Tortellini cheese
- *8 Ounces of fresh Asparagus, fresh, and cut Into 2 inch pieces
- *1/2 Cup of bottle Ranch Salad Dressing
- *1 Lime
- *2 Tablespoons of grated Parmesan cheese
- *Cracker Pepper

Directions:

- *Cook Tortellini in a large sauce pan
